2. INFORMATION WE COLLECT

2.1 Information You Provide Directly

Contact Form:

When you submit our contact form, we collect:

- Full Name
- Email Address
- Message/Inquiry

Newsletter Subscription:

When you subscribe to our newsletter through MailerLite, we collect:

- Email Address only

2.2 Information Collected Automatically via Cookies and Tracking Technologies

We use the following tools that place cookies and tracking technologies on your device:

Google Analytics 4 (GA4):

- Tracks website traffic, user behavior, page views, time on site, and general location data
- Uses cookies: _ga, _gid, ga[measurement ID]

- **Category:** Analytics

Meta Pixel (formerly Facebook Pixel):

- Tracks conversions, user interactions, and helps build advertising audiences
- Uses cookies for conversion tracking and retargeting
- **Categories:** Analytics, Marketing

Chatbase (Chatbot):

- Provides live chat functionality embedded on the website
- **Contact Chatbase to find out about tracking**
- Tracks your interaction with the chatbot for functionality purposes
- **Categories:** Analytics, Personalization, Marketing

3. COOKIE CATEGORIES AND CONSENT

Our Site uses cookies and tracking technologies in the following categories:

3.1 Essential Cookies

- Required for website functionality
- Do NOT require user consent
- Examples: Session cookies, security tokens

3.2 Analytics Cookies

- Used to understand how you interact with our Site
- **Requires consent:** YES
- **Tools:** Google Analytics 4, Meta Pixel, Chatbase
- **Purpose:** Measure website performance and user behavior

3.3 Marketing Cookies

- Used for advertising, retargeting, and audience building
- **Requires consent:** YES
- **Tools:** Meta Pixel, Chatbase
- **Purpose:** Show relevant ads and measure advertising effectiveness

3.4 Personalization Cookies

- Used to enhance your browsing experience
- **Requires consent:** YES
- **Tools:** Chatbase
- **Purpose:** Remember your preferences and chat interactions

4. COOKIE CONSENT BANNER

4.1 How Our Cookie Banner Works

When you visit our Site for the first time, a cookie consent banner appears with the following options:

1. **Accept All:** Accepts all non-essential cookies (Analytics, Marketing, Personalization)
2. **Reject All:** Rejects all non-essential cookies; only Essential cookies remain active
3. **Preferences:** Allows you to choose which cookie categories to accept/reject individually

4.2 Script Blocking

- Until you provide consent, the following scripts are **blocked and do not execute:**
 - Google Analytics 4
 - Meta Pixel
 - Chatbase (non-essential functionality)
- Essential scripts (website functionality) always remain active

4.3 Consent Management

- Your cookie choices are saved in your browser
- You can change your preferences at any time by accessing the cookie banner again
- Withdrawing consent is as easy as providing it

5. LEGAL BASIS FOR DATA PROCESSING

5.1 Contact Form Data

- **Legal Basis:** Legitimate Interest (Art. 6(1)(f) GDPR) - to respond to inquiries and provide customer service
- **Purpose:** Receive and respond to your contact requests

5.2 Newsletter Data

- **Legal Basis:** Consent (Art. 6(1)(a) GDPR)
- **Opt-In Type:** Single Opt-In (email added to list upon subscription)
- **Purpose:** Send marketing communications and newsletters
- **Frequency:** Approximately monthly

5.3 Analytics Cookies (GA4, Meta Pixel, Chatbase)

- **Legal Basis:** Consent (Art. 6(1)(a) GDPR)
- **Purpose:** Analyze website performance, user behavior, and advertising effectiveness
- **Consent Method:** Cookie consent banner (Accept All / Preferences)

5.4 Marketing Cookies (Meta Pixel, Chatbase)

- **Legal Basis:** Consent (Art. 6(1)(a) GDPR)
- **Purpose:** Build advertising audiences, track conversions, and retarget users
- **Consent Method:** Cookie consent banner (Accept All / Preferences)

6. DATA RETENTION

We retain personal data for the following periods:

After the retention period expires, data will be deleted or anonymized.

- **Purpose:** Email marketing platform for newsletter distribution
- **Data Processed:** Email addresses
- **Location:** USA

- **Compliance:** MailerLite maintains GDPR compliance via Standard Contractual Clauses (SCC)

7.2 Google Analytics 4

- **Purpose:** Website analytics and traffic analysis
- **Data Processed:** Browsing behavior, IP address (anonymized), cookies, event data
- **Location:** USA
- **Data Processing Agreement:** <https://support.google.com/analytics/answer/6004245>

- **Compliance:** Google maintains standard Data Processing Agreements per GDPR Article 28

7.3 Meta Pixel

- **Purpose:** Conversion tracking and advertising audience building
- **Data Processed:** Browsing behavior, cookies, conversion events, device identifiers
- **Location:** USA
- **Data Processing**
Agreement: https://www.facebook.com/legal/terms/business_tools
- **Compliance:** Meta maintains standard Data Processing Agreements per GDPR Article 28

7.4 Chatbase

- **Purpose:** Live chat functionality and support
- **Data Processed:** Chat messages (not automatically tracked as cookies), interaction data
- **Location:** Canada
- **Data Processing Agreement:** Available upon request at support@chatbase.co
- **Compliance:** Chatbase maintains GDPR compliance; Canada has EU adequacy decision (Art. 45 GDPR)

7.5 cPanel Hosting Provider

- **Purpose:** Website hosting, storage, and infrastructure
- **Data Processed:** All website data, contact form submissions, user-generated data
- **Location:** Hungary
- **Data Processing Agreement:** Available upon request from hosting provider
- **Compliance:** cPanel maintains standard data protection practices compliant with GDPR Article 28

8. INTERNATIONAL DATA TRANSFERS

8.1 Transfer to USA-Based Services

Your personal data may be transferred to the United States for processing by:

- Google (Google Analytics 4)
- Meta (Meta Pixel)
- MailerLite

These transfers are governed by **Standard Contractual Clauses (SCC)** in accordance with GDPR Article 46.

8.2 Transfer to Canada

Chatbase is located in Canada, which has an **adequacy decision** under GDPR Article 45, meaning data protection is deemed equivalent to the EU.

8.3 Your Rights Regarding Transfers

By using our Site, you consent to these international data transfers. You have the right to object to such transfers or request information about the safeguards in place.

9. YOUR RIGHTS UNDER GDPR

You have the following rights regarding your personal data:

9.1 Right of Access (Art. 15)

You can request access to all personal data we hold about you.

9.2 Right to Rectification (Art. 16)

You can request correction of inaccurate or incomplete personal data.
